NOTULA RAPAT PLENO SEKRETARIAT NASIONAL ASEAN
4 OKTOBER 2023

1. Rapat Pleno Sekretariat Nasional (Setnas) ASEAN telah diselenggarakan secara *hybrid* pada 4 Oktober 2023. Rapat dipimpin Direktur Jenderal Kerja Sama ASEAN selaku Pelaksana Harian Setnas ASEAN serta diikuti oleh Anggota Setnas ASEAN dan Kementerian/Lembaga (K/L) terkait.
2. Agenda utama rapat adalah sosialisasi dan identifikasi rencana tindak lanjut dari hasil-hasil Rangkaian Konferensi Tingkat Tinggi (KTT) ke-43 ASEAN dan KTT Terkait Lainnya yang telah terlaksana pada tanggal 2-7 September 2023 di Jakarta.
3. K/L sepakat untuk menindaklanjuti 90 *outcome documents* hasil rangkaian KTT dimaksud (daftar dokumen terlampir), yang didasari oleh empat pilar Ketetuaan Indonesia di ASEAN 2023:
 - a. Meletakkan Visi Jangka Panjang ASEAN, dengan diadopsinya **ASEAN Concord IV** yang menjadi fondasi bagi Visi Jangka Panjang ASEAN Tahun 2045.
 - b. ASEAN Matters
 - i. Disepakatinya Premis ASEAN menjadi *ASEAN Headquarters* (ASEAN HQ) untuk memperkuat diplomasi sentralitas ASEAN di Jakarta.
 - ii. Pemajuan kerja sama maritim.
 - iii. Pemajuan dan perlindungan Hak Asasi Manusia (HAM).
 - c. ASEAN Sebagai Pusat Pertumbuhan (*Epicentrum of Growth*)
 - i. Penguatan arsitektur kesehatan global.
 - ii. Penguatan keamanan dan ketahanan pangan.
 - iii. Keamanan dan transisi energi.
 - iv. Penguatan stabilitas keuangan.
 - v. Penanganan perubahan iklim dan manajemen bencana.
 - vi. Penguatan kapasitas sumber daya manusia.
 - vii. Pembentukan status kemitraan baru.
 - d. Menjadikan Indo-Pasifik sebagai Kawasan damai sejahtera melalui pendekatan kerja sama konkret yang inklusif (*ASEAN Outlook on the Indo-Pacific*)
 - i. Terlaksananya *ASEAN-Indo-Pacific Forum* (AIPF) yang menghasilkan 93 proyek kerja sama dengan nilai USD 38,2 miliar; serta 73 proyek potensial senilai USD 17,8 miliar di berbagai sektor.
 - ii. Penandatanganan nota kesepahaman ASEAN dengan *Pacific Islands Forum* (PIF) dan *Indian Ocean Rim Association* (IORA).

4. Rangkaian KTT juga membahas perkembangan isu Myanmar, dan menyetujui usulan Indonesia untuk mengadopsi *ASEAN Leaders' Review and Decision on the Implementation of the Five Point Consensus* yang memuat beberapa hal, di antaranya:
 - a. Penegasan *Five-Point Consensus* (5PC) sebagai referensi utama ASEAN.
 - b. Pertahankan keputusan *non-political representation* Myanmar di KTT dan Pertemuan Menlu ASEAN.
 - c. Myanmar tidak menjadi Ketua ASEAN pada 2026, dan akan digantikan Filipina.
 - d. Memastikan keberlanjutan pendekatan dan strategi ASEAN untuk bantu Myanmar, melalui mekanisme konsultasi informal (troika).
5. Berbagai *outcome document* yang dihasilkan dari Rangkaian KTT ke-43 ASEAN dan KTT Terkait Lainnya dapat diakses melalui:

6. Rapat mencatat beberapa masukan K/L, di antaranya:
 - a. Apabila tindak lanjut hasil-hasil dimaksud berimplikasi pada adanya komitmen atau inisiasi baru yang perlu segera ditindaklanjuti (seperti proses pengesahan), maka perlu segera dibuat lini masa yang jelas agar tidak terkendala proses di dalam negeri. Selain itu, sesuai dengan Perpres 30/2019, sekiranya ada perubahan komitmen atau komitmen baru, maka perlu dilaporkan kepada Pokja KKOI untuk mendapatkan rekomendasi Menteri Luar Negeri.
 - b. Untuk menindaklanjuti visi Indonesia sebagai Ibukota Diplomasi Kawasan, Indonesia perlu konsisten untuk memberi fasilitas diplomatik antara Misi ASEAN dengan Perwakilan Diplomatik Bilateral (misalnya pembebasan bea masuk).
→ Ke depannya perlu dilakukan pembahasan lebih lanjut dengan K/L terkait, misalnya dengan Ditjen Bea Cukai, Ditjen Imigrasi.
 - c. Untuk menindaklanjuti kesepakatan Premis ASEAN menjadi ASEAN HQ, perlu didiskusikan mengenai kemungkinan beberapa *ASEAN Centre* yang saat ini telah berdiri di Indonesia untuk digabungkan di ASEAN HQ.
 - d. K/L perlu bersama-sama mengawal dan memimpin inisiasi dalam menindaklanjuti *ASEAN Leaders' Declaration on Strengthening Food Security and Nutrition in Response to Crises*. Deklarasi ini dianggap dapat membuka potensi besar bagi pengembangan daerah-daerah di Indonesia.
 - e. Perlu dikembangkan kerja sama pemerintah daerah di Indonesia dan luar negeri, khususnya dalam hal Tindak Pidana Perdagangan Orang (TPPO), yang dinilai telah menjadi kunci kesuksesan penegakkan hukum lintas batas selama ini sehingga pengembangannya harus terus dilakukan
7. Rapat juga mencatat hasil-hasil pertemuan yang telah berlangsung selama Keketuaan Indonesia di ASEAN, pertemuan yang masih akan berlangsung selama beberapa bulan ke depan, serta tindak lanjut dari berbagai sektor di seluruh pilar. Rapat menyepakati bahwa forum Setnas ASEAN akan dimanfaatkan sebagai media koordinasi, diskusi dan pengambilan langkah bersama.
